CERTIFICATE

Certified that the Education Department of the Government of the State of Karnataka has no objection to the affiliation of Diya Academy Learning, Survey NO. 70/1, and 71 Hoodi Village, Krishnarajapura Hobli, Bangalore East Taluk, Bangalore, run by August Foundation, No. 188/1, Rehan, 6th Main Road, H.A.L. 2nd Stage, Bangalore – 560038, to the Central Board of Secondary Education, New Delhi.

This No Objection Certificate is issued subject to the following conditions:-

- (1) The management shall impart education to the pupils from Standard I to V in Kannada medium or in the mother tongue of the pupil and shall teach Kannada compulsorily as one of the languages as per the policy prescribed by the Government of Karnataka.
- (2) The management shall not collect any donation from the students or their parents/guardians and collect only the fees prescribed by Government from time to time as per the provisions of the Karnataka Educational Institutions(Abolition of Capitation Fee) Act, 1984 or as prescribed by the Central Board of Secondary Education, New Delhi.
- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
- (4) Admission to pre- primary stage, should be done in the month of April every year.
- (5) The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the Chambers of the Principal/Head Master/Head Mistress, for the benefit of general public.

- (6) For starting the pre-primary school (Nursery/LKG /UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- (7) Any other conditions that may be imposed in future.
